Nassau County Tries to Pass the Buck to School Districts

During the course of the last year, the Nassau County Legislature initiated two actions that could have significant impact on school districts, including Rockville Centre. Both of these legislative actions shift the financial burden from the County to local school districts.

The first action involves Nassau County Legislature's approval of legislation that shifts the financial responsibility for multi-year back payments for tax certiorari settlements from the County to school districts. Tax certiorari proceedings are the legal process by which a property owner can challenge the real estate tax assessment on a given property in an attempt to reduce the property's assessment and real estate taxes.

Earlier this year Rockville Centre, along with other school districts, the Nassau-Suffolk School Boards Association, and other municipalities brought a lawsuit against the County. This consolidated lawsuit is pending before a justice in the Supreme Court of Nassau County. In the past, attempts by the County to shift the burden to school districts and towns have been denied by both the State Supreme Court and the Appellate Division.

Rockville Centre's tax certiorari liability could approximate \$1.3 million each year. School district business offices will be responsible for tracking tax certiorari claims and legal counsel will be needed to handle the tax certiorari proceedings creating an additional legal burden.

The second action involves an attempt by Nassau County to impose sewer use charges on school districts which had previously been "exempt users." Rockville Centre joined with other school districts and other users classified as exempt, including Hofstra University and St. Francis Hospital, to successfully argue a motion seeking a preliminary injunction preventing the enforcement of the imposition of the sewer use fees while this litigation proceeds.

Since the County does not have sewer meters, these fees would be measured solely on total water consumption. School districts would be at a disadvantage because of high water use for irrigating fields, as would schools with pools. At this time there are no County plans to install sewer meters to measure the volume of water flowing into the sewers from the school districts.
