On March 21, 2016, the Board of Regents adopted emergency regulations to amend and implement Education Law §3006 requiring all individuals holding a teaching certificate in the classroom teaching service, a Level III teaching assistant certificate or educational leadership certificate valid for life to register with the State Education Department (SED) every five years, commencing with the 2016-2017 school year.

Regulations require registration for:

- The "classroom teaching service" includes teachers and those in the administrative supervisory service. Educational leadership service includes the certificate titles of school building leader, school district leader, and school district business leader.
- Practicing employed 90 days or more during a school year by an applicable school, and a day of employment is defined to include a day actually worked in whole or in part, or a day not actually worked but a day paid.
- Teaching Assistants holding a Level III certificate
- Excluded are those who hold a pupil personnel service certificate (e.g. school counselors, school social workers and school psychologists)
